

Statement of Purpose and Literature Review

The *Society of Podiatric Organization Volunteerism* was founded in 2024 to investigate, recognize, encourage and support the concept of volunteerism throughout the podiatric profession [1-4].

The objective of this investigation was to describe a cross-section of professional service positions in the podiatric profession during the 2023-2024 academic year. The specific aims were to 1) recognize multi-organizational volunteerism in service positions, 2) promote collaboration and cooperation between organizations, and 3) provide organizations with a visual representation of potential areas for growth.

Methodology

Data was collected predominantly from publicly available information published through individual organization newsletters and websites during the 2023-2024 academic year. We considered 4 professional services positions: residency program directors from CPME-approved residency programs, fellowship program directors from ACFAS-recognized and CPME-approved fellowships, delegates and alternates the 2024 APMA House of Delegates, and faculty from the 11 CPME-approved podiatric medical colleges.

For the purposes of this investigation, we considered "volunteers" as Doctors of Podiatric Medicine identified by the respective organizations as serving as a committee member or as a volunteer. Students and non-DPMs were excluded from the analysis. Websites were accessed in September of 2024.

-Residency Program Directors: Program directors from CPME-approved residency programs were identified on the CPME website. (Available at: https://www.cpme.org/residencies/list-of-approved-residencies/)

-<u>Fellowship Program Directors</u>: Program directors from CPME-approved and ACFAS-recognized fellowship programs were identified on the CPME and ACFAS websites. (Available at: https://www.cpme.org/fellowships/list-of-approved-fellowships/ and https://www.acfas.org/professional-resources/fellowship-resources/list-of-fellowships-with-acfas-status)

-APMA House of Delegates: Delegates and alternates from the 2024 APMA House of Delegates were included.

-<u>Podiatric Medical School faculty</u>: Individuals listed as full-time faculty on the websites of the 11 colleges of podiatric medicine accredited by the CPME were included in the analysis. (Available at: https://www.cpme.org/podiatric-medical-colleges/list-of-podiatric-medical-colleges/)


-ABPM (American Board of Podiatric Medicine): A list of ABPM volunteers was provided by the ABPM executive director following an email request in September of 2024.

Discussion

As with any scientific investigation, critical readers are encouraged to review the study design and specific results in order to reach their own independent conclusions, while the following represents our conclusions based on the preceding results. We also never consider data to be definitive, but do think that these results might be worthy of attention and future investigation.

- -This investigation aimed to describe volunteerism within podiatric professional service positions during a specific time frame of the 2023-2024 academic year. Our conclusions are intentionally generalized, broad, noncomparative, and supportive of all organizational volunteerism.
- ---We observed substantial volunteerism of individuals in podiatric professional service positions. Residency program directors and fellowship program directors in particular demonstrated overlap with other national professional organizations during this time frame, and high rates of board qualification/certification.
- -There are certainly some limitations to consider with this project:
- ---This is a cross-section methodology describing a single period of time, and does not demonstrate or describe patterns or trends. However, it is our intention to repeat this project every 2-3 years in order to elucidate potential trends.
- ---The term "volunteer" is subjective and likely varies from organization to organization. The reporting and recognition of volunteers by individual organizations is also variable. Hopefully these results encourage organizations to evaluate their practices and appropriately recognize their volunteers for their contributions.
- ---There are likely other professional service positions and national podiatric organizations with volunteers not included here.
